MR. CERMAK MADE A MOTION TO APPROVE THE APRIL 16, 2008 REGULAR MONTHLY MEETING MINUTES AND THE MAY 8, 2008 SPECIAL MEETING MINUTES. MR. GUNTHER SECONDED THE MOTION. ALL IN FAVOR, MOTION CARRIED.

MR. LARRICK MADE A MOTION TO APPROVE THE POLICE DEPARTMENT REPORT, FIRE DEPARTMENT REPORT, MAGISTRATE REPORT, ANIMAL WARDEN REPORT, ROAD DEPARTMENT REPORT AND CODE ENFORCEMENT OFFICER REPORT. MR. KOKOSKI SECONDED THE MOTION. ALL IN FAVOR, MOTION CARRIED.
