

JANUARY 8, 2008 REORGANIZATION MEETING OF THE HARMONY
TOWNSHIP BOARD OF COMMISSIONERS

THE SECRETARY EXPLAINED THAT THE OATH OF OFFICE WAS
PREVIOUSLY ADMINISTERED BY JOHN B. CERMAK, NOTARY TO GLENN
ANGUS AND PAUL KOKOSKI.

THE SECRETARY ASKED FOR NOMINATIONS FOR THE CHAIRMAN OF THE
BOARD. MR. KOKOSKI NOMINATED MR. ANGUS. AFTER A UNANIMOUS
ROLL CALL VOTE, MR. ANGUS WAS APPOINTED CHAIRMAN OF THE
HARMONY TOWNSHIP BOARD OF COMMISSIONERS

AND VOTE.
